Entry

2. Entries are deemed to be received at the time of receipt by the Promoter and not at the time of transmission by the entrant.
3. The Promoter reserves the right, at any time, to verify the validity of entries and entrants (including an entrant's identity, details and VCCI membership) and to disqualify any entrant who submits an entry that is not in accordance with these Terms and Conditions or who tampers with the entry process. Failure by the Promoter to enforce any of its rights at any stage does not constitute a waiver of those rights.
