with the Rule of Origin (ROO) requirements of the Agreement as detailed in Chapter 3 “Rules of Origin” and the relevant Appendixes.

To ensure the integrity of CO certification process, the company provides the Victorian Chamber with a list of names and signatures of  
people whom it has authorised to sign such documents on its behalf. The list is on the reverse side of this form.

The company agrees to advise the Victorian Chamber, in writing, of:

- \* the names and signatures of any additional persons authorised by the company to sign applications for documentary  
evidence of origin (Certificates of Origin), Certificates of Free Sale or visa letters;
- \* the withdrawal of any persons from the Signatory List; and
- \* any change in address details.

In respect of the issue of documentary evidence of origin, the company will ensure that the Victorian Chamber is provided with any  
documents or information which it may request to enable it to be satisfied that the goods, for which a documentary evidence of origin is  
sought, do originate from the country certified as determined by the rules of origin of the destination country.
